The Government of Rwanda has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Rwanda Sustainable Water and Sanitation Program, and intends to apply part of the proceeds toward payments under the contract for the Construction of Kivu Belt Water Supply System (Phase I). For this contract, the Borrower shall process the payments using the Direct Payment disbursement method as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing.
2. The Water and Sanitation Corporation (WASAC Ltd) now invites sealed Bids from eligible Bidders for the Construction of Kivu Belt Water Supply System (Phase I). The works include General Preliminary works, Construction of raw water intake, water treatment plant of 13,000m<sup>3</sup>/day, concrete Tanks and Pressure Breakers, inspection chambers and water points, Supply and laying of pipes of 124km and Construction and installation of pump station.  
  
The works will be executed in Rutsiro District and Karongi Districts, Western Province for a period of 18 months. Defect liability period: 12 months.
3. Bidding will be conducted through the Open Competitive Bidding (International), OCBI procedures as specified in the Bank's [Procurement Framework](#) (Procurement Policy for Bank Group Funded Operations dated October 2015) and is open to all eligible Bidders as defined in the Procurement Framework.
4. Interested eligible Bidders may obtain further information from Water and Sanitation Corporation (WASAC), Procurement Manager, E-mail: [procurement@wasac.rw](mailto:procurement@wasac.rw) and inspect the bidding document during office hours **07:00am to 05:00pm local time (5:00am-03:00pm GMT)** at the address given below.

5. The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **Ten Thousand Rwandan Francs only (10,000 Frw)** or in any freely convertible currency. The method of payment will be to deposit the tender fee to the account N° **100009564367 of WASAC opened at Bank of Kigali**. The bidding document may be sent by email as may be requested by interested bidders (through the request addressed to [procurement@wasac.rw](mailto:procurement@wasac.rw)).
6. Bidders are advised to attend (optional) the planned sites visit in order to acquaint themselves with existing conditions. The Sites visit will take place on **29<sup>th</sup> September 2022** and the place of departure is at Karongi District Offices at **10:00 a.m. local time (08h00a.m. GMT)**. An online pre-bidding meeting is organized, to help bidders gain a better understanding of project details, scope of work, tender documents, and any other requirements needed to be considered for the job. The online pre-bidding meeting will be held on **4<sup>th</sup> October 2022 at 10:00 am local time (8:00am GMT)**. Prospective bidders are required to submit the details (Names, Position & Email address) for their representatives who will attend the pre-bid meeting at least two days before the meeting.
7. Bids must be delivered at WASAC Head Office at the address given below not later than **9<sup>th</sup> November 2022 at 10:30a.m. local time (8:30a.m. GMT)**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders 'designated representatives and anyone who chooses to attend on **9<sup>th</sup> November 2022 at 11:00a.m. local time (9:00a.m. GMT)** in the Board Room of WASAC Head Office at the address below.
8. All Bids must be accompanied by a Bid Security of an amount of **Seventy-Five Thousand United States Dollar (US\$75,000)** or its equivalent amount in a freely convertible currency.
9. Attention is drawn to the Procurement Framework requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
